AND WHEREAS, Flying Squad Team during site inspection on 13/10/2021 observed that you have done hill cutting is carried out measurement 30 x 5 x 6 mtrs and Construction of residential house is in progress in the same plot of Village Taleigao in Taluka Tiswadi and there was no information board displayed at the site displaying the permission from the Town and Country Planning Department nor any document/ permission were made available at the site and as such, prima facie, it attracts Section 17-A of the Town and Country Planning Act, 1974 which is a cognizable offence.
